**MOTION TO MODIFY AND EXTEND EX PARTE TEMPORARY RESTRAINING
ORDER AND ORDER SETTING HEARING FOR TEMPORARY ORDERS**

This Motion to Modify and Extend Ex Parte Temporary Restraining Order and Order Setting Hearing for Temporary Orders is brought by Petitioner Gwendolyn Uljasz-McKemie, who shows in support:

On December 18, 2024, an Ex Parte Temporary Restraining Order and Order Setting Hearing for Temporary Orders was issued, and a hearing was set for December 31, 2024, at 1:30 p.m.

Due to an inability to obtain the evidence and witnesses required, within the fourteen-day period, the temporary orders hearing on this matter needs to be reset. Petitioner is still in the process of attempting to recover multiple files and evidence deleted from her computer and iCloud, as well as removing the malware that was used on her devices.

Good cause exists for extension of the Ex Parte Temporary Restraining Order because the temporary restraining order will expire on December 31, 2024, before a hearing can be held in this matter and before Petitioner will be able to access the documents required for the hearing.

In addition, Petitioner has relocated since the issuance of the original Ex Parte Temporary Restraining Order and requests that the Court modify the temporary restraining order to apply to her new residence.

Gwendolyn Uljasz-McKemie prays that the Court grant this Motion to Modify and Extend Ex Parte Temporary Restraining Order.




