**EMERGENCY EX PARTE MOTION TO AUTHORIZE WITHDRAWAL FROM IRA**

---

**TO THE HONORABLE JUDGE OF SAID COURT:**

Respondent, **Jason McKemie**, appearing pro se and **not by choice**, respectfully files this **Emergency Motion to Authorize Withdrawal from IRA** and would show the Court as follows:

1. **NARROW RELIEF REQUESTED:**

Respondent requests immediate authorization to **withdraw \$6,500 from his IRA** (Ameriprise account) to prevent imminent repossession of his vehicle, reinstate car insurance, avoid utility shutoffs at the marital residence, and purchase essential prescriptions.

---

2. **COMMUNITY PROPERTY:**

The parties acknowledge that the date of marriage and the characterization of retirement assets as community or separate property are contested issues reserved for determination at trial. Nothing in this Motion or Order shall be construed as a concession, waiver, or adjudication of those issues. This request is limited solely to authorizing a one-time emergency withdrawal and is made without prejudice to either party's claims or defenses.

---

3. **IMMEDIATE AND IRREPARABLE: HARM:**

The requested withdrawal **represents \$6,500 out of approximately \$495,000 in retirement assets (<1.5%)**. Without this relief *today*, Respondent faces repossession of his only transportation, disconnection of utilities, and interruption of critically necessary services.

---

4. **SCOPE OF REQUEST:**


This withdrawal is narrowly tailored, limited to contributions originally deposited into the IRA, and **will not diminish or prejudice the remaining retirement assets of either party**. Respondent seeks only the minimum necessary to prevent immediate irreparable harm, with the withdrawal structured to avoid penalties and ensure no adverse impact to Petitioner or the marital estate. This request addresses only today's urgent need, with broader issues of record integrity, financial conduct, and due process reserved for subsequent filings.

---

5. **PRAYER:** WHEREFORE, Respondent respectfully prays that this Court:

- Immediately authorize withdrawal of \$6,500 from Respondent's IRA at Ameriprise for the limited purposes stated herein;
  - Grant such other and further relief to which Respondent may be justly entitled.

## ORDER AUTHORIZING WITHDRAWAL FROM IRA

**IT IS THEREFORE ORDERED that:**

**1. Authorization of Withdrawal**

Respondent, Jason McKemie, is authorized to withdraw **Six Thousand Five Hundred Dollars (\$6,500.00)** from his Ameriprise IRA Account ending in **x8133**.

**2. Immediate Processing**

The IRA custodian, Ameriprise, is hereby **ORDERED to process the withdrawal immediately upon receipt of this Order** and to release funds to Respondent without delay. **Same-day turnaround is directed** to the fullest extent practicable.

**3. Non-Interference**

Petitioner, **Gwendolyn Ulijasz-McKemie, is ORDERED to take no action**, directly or indirectly, to obstruct, delay, cancel, or otherwise interfere with Respondent's access to the funds authorized by this Order.

**4. Without Prejudice**

This Order is entered solely to address an immediate emergency. It is **without prejudice** to the Court's final characterization or division of marital assets and expressly preserves Respondent's right to seek further relief, including sanctions, restitution, and offsets for waste or concealment.

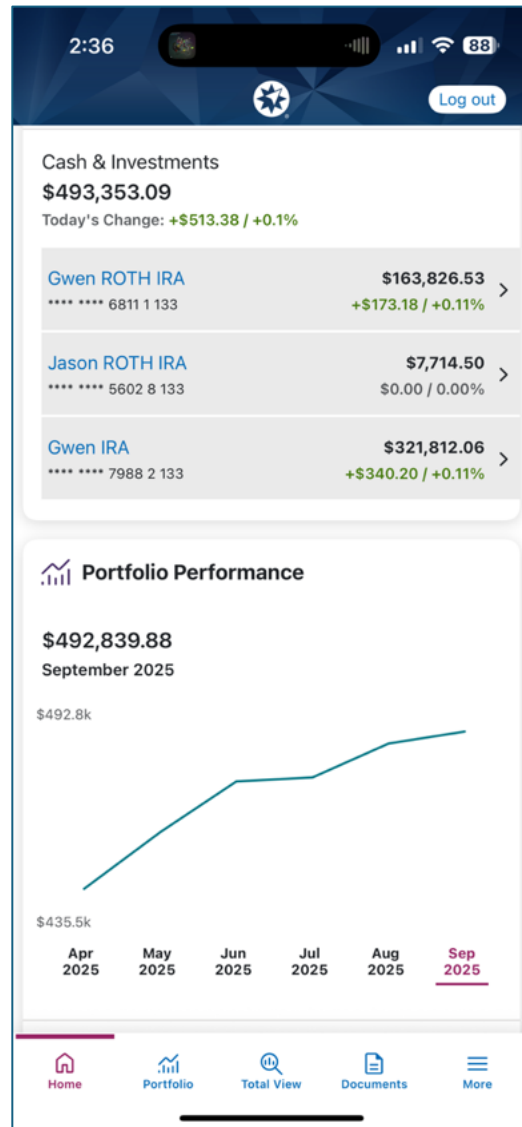

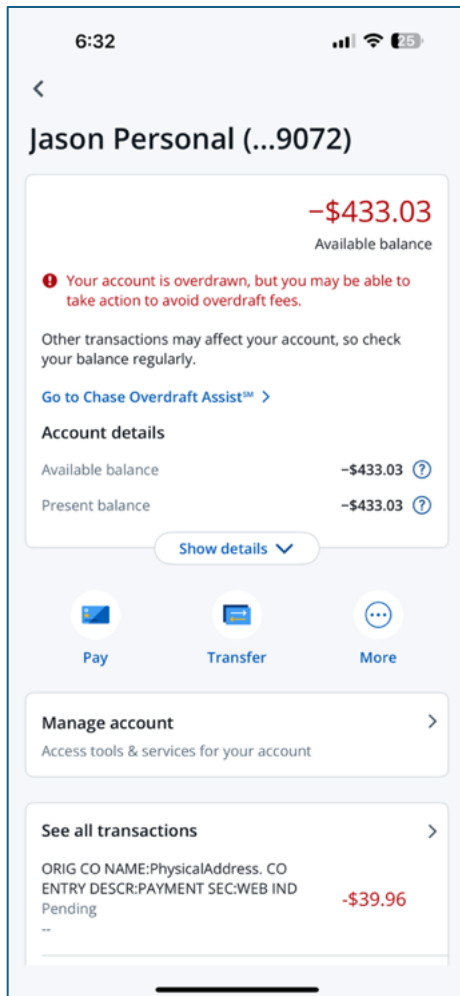
