COMES NOW, Jason McKemie, Petitioner, and respectfully files this Notice to inform the Court of the following:

- I. Mediation in this matter did not result in a signed or enforceable agreement. No final agreement was executed by the parties.
- II. Petitioner is currently unrepresented, as prior counsel has formally withdrawn.
- III. Petitioner respectfully requests additional time to retain legal representation before the upcoming pre-trial hearing.
