**NOTICE OF SUPPLEMENTAL FILING TO BE  
SUBMITTED TODAY AND MOTION FOR LEAVE**

Jason McKemie files this Notice and Motion and respectfully states:

1. On the prior filing, Movant stated that a supplemental submission would be filed by 8:00 a.m. this morning (April 6th, 2026).
2. The supplemental filing remains in active preparation. Respondent anticipates filing it later today, but respectfully requests a brief 24-hour extension if needed to submit the finalized pleading. This notice is filed to keep the Court informed and to preserve Respondent's right to timely supplement the prior objection.
3. The remaining work reflects final assembly, issue narrowing, and formatting necessary to present a focused and usable submission rather than an incomplete filing.
4. Movant is proceeding without counsel, under severe financial and medical strain, while also attempting to secure employment necessary for immediate stabilization. Movant is working to complete the supplement as quickly as possible and is making this notice promptly so the Court is informed before the earlier estimated time passes.
5. Movant is additionally returning to town from Bryan, Texas, where his family spent the weekend assisting his elderly parents, including a father in severe memory decline, with temporary relocation, sale of personal belongings and residence, and associated logistics. These circumstances arise from the severe financial fallout directly tied to these proceedings and are addressed in motions being submitted this week.
6. Movant does not seek delay for its own sake. Movant seeks only a brief 24 hour extension to complete the supplement in final form.
7. To the extent leave is required for the supplemental filing, Movant requests leave of Court to file the supplement later today or by morning at the latest.

**PRAYER**

Movant respectfully requests that the Court accept this Notice, grant leave for the supplemental filing to be submitted no later than 24 hours from the filing of this notice.
