**PETITIONER'S OBJECTION TO UNFILED AND UNSERVED MOTION TO
RECUSE AND REQUEST FOR IMMEDIATE RESET**

TO THE HONORABLE 302nd COURT:

Petitioner files this Objection and respectfully shows:

1. Today, February 24, 2026, and immediately prior to the scheduled final trial setting, Respondent handed a document titled "Verified Motion to Recuse" directly to the Court in open session. Petitioner was not provided copy she proactively requested it near the end of the discussion in court.
2. The document was not filed with the clerk prior to trial and did not appear on the Court's docket at the time proceedings were halted.
3. Petitioner was not served with the motion prior to trial and was provided no meaningful opportunity to review the approximately forty (40) page document before the Court ceased proceedings.
4. As of the time of this filing, no Motion to Recuse appears on the official docket in this cause.
5. Texas Rule of Civil Procedure 18a requires that a motion to recuse be filed with the clerk, verified, and served upon all parties with 10 days advance notice. The rule does not authorize interruption of a duly set trial based on an unfiled or unserved document.
6. Petitioner objects to any delay of these proceedings based upon a procedurally defective or unfiled motion.
7. This matter has already been substantially delayed due to prior recusal proceedings in Court 254 in July 2025. Further delay without compliance with Rule 18a materially prejudices Petitioner's right to final resolution.

WHEREFORE, PREMISES CONSIDERED, Petitioner respectfully requests:


A. Clarification as to whether any Motion to Recuse has been properly filed and referred pursuant to Rule 18a;

B. In the absence of proper filing and service, immediate reinstatement of this matter to the trial docket at the earliest available setting;

C. If a motion has since been filed, expedited referral and resolution of the recusal issue;

D. Such other relief to which Petitioner may be entitled.


