**ORDER AUTHORIZING THE REMOTE TESTIMONY OF
CHRISTOPHER McNALLY & OVERRULING WITNESS-STRIKE OBJECTIONS**

On this day, the Court considered **Movant's (Jason McKemie's) Motion for Remote Testimony of Witness Christopher McNally by Videoconference and to Overrule Witness-Strike Objections Based on Third-Party Protective Order**. After considering the Motion, the record, and arguments of the parties, the Court finds the requested relief should be **GRANTED**.

All communications regarding scheduling, videoconference access, and logistics shall be limited to Movant and/or the Court and shall not be used to convey messages to Petitioner.
