ORDER ON EMERGENCY TRO

On this day, the Court considered Respondent's **Emergency Application for Temporary Restraining Order for Immediate Temporary Support to Prevent Eviction and Maintain Status Quo**. The Court finds that immediate and irreparable harm will occur before notice and hearing can be completed unless temporary relief is granted, and that such relief is necessary to preserve the status quo pending a return hearing.

IT IS ORDERED:**1. IMMEDIATE TEMPORARY SUPPORT**

- Petitioner shall tender (CHECK OR STRIKE THROUGH:

- to Respondent by **2:00pm on the Date of Signing**, by electronic transfer to Respondent's account ending **XX6893**.

2. PROOF OF COMPLIANCE

- Petitioner shall file **written proof of compliance** via e-file no later than 1 hour beyond the deadline.

3. COERCIVE COMPLIANCE INCENTIVE

- **To promote prompt and complete compliance** and to prevent irreparable harm, this Order includes a **one-time coercive compliance incentive equal to two (2) weeks of Petitioner's gross compensation**, which the Court finds measured and proportionate based on Petitioner's demonstrated ability to comply. Based on Petitioner's represented compensation, this amount is **\$67,500**.
 - Timely compliance with all requirements of this Order **within twenty-four (24) hours of execution** of this Order will fully satisfy this incentive. **Noncompliance with any requirement beyond that period shall cause the incentive to become immediately due and payable to Respondent in the stated amount**, without further order of the Court.
 - **In addition**, beginning immediately upon expiration of the **twenty-four (24) hour** period, Petitioner shall incur a **coercive monetary fine of \$2,500 per day**, accruing **automatically and without further order of the Court**, until full compliance with this Order is completed.
 - Each day of continued noncompliance constitutes a **separate and continuing violation**.

3. EVICTION RESTRAINT / STATUS QUO

- Petitioner and any persons acting in concert are **restrained from eviction or lockout** of Respondent pending further order of the Court.
-

4. PROPERTY PROTECTIONS

- **Non-Abandonment.** Respondent shall **not be deemed to have abandoned** any personal property by compliance with this Order, any temporary relocation, or inability to remain due to eviction proceedings.
- **Mutual Preservation.** Neither party shall remove, dispose of, conceal, damage, encumber, or interfere with any personal or marital property located at the residence pending further order of the Court, except by written agreement or court order.

- **No Unilateral Inventories/Claims.** No party may unilaterally inventory, designate, or claim exclusive ownership of household property during the pendency of this Order.
 - **Neutral Handling.** Any necessary removal or storage shall occur only by mutual agreement or a neutral third party and shall **not** constitute abandonment or waiver of claims.

5. NO RETALIATION / INTERFERENCE

- Petitioner shall not retaliate against or interfere with Respondent's housing stability, access to funds, or medical care pending further order.
-

6. RETURN HEARING

- The Clerk shall set an **expedited return hearing** before the District Judge at the earliest available date.
-

7. NON-OFFSET

- Any coercive payment or accrual imposed under this Order is an **enforcement remedy** and shall not be treated as a division of property, advance against community assets, or offset against Respondent's share of the marital estate.
