## MANUFACTURED ALLEGATIONS

### STATE OF TEXAS | COUNTY OF DALLAS

BEFORE ME, the undersigned authority, on this day personally appeared **Jason McKemie**, who, being duly sworn, stated under oath as follows:

1. **My name is Jason McKemie** and my **Date of Birth is April 8th, 1976**. I am the **Respondent** in **Cause # DF-24-18010** in **Dallas County, Texas**. I am over the age of eighteen (18), of sound mind, competent to make this affidavit, and all statements herein are based on my personal knowledge and are true and correct.
2. On **December 18, 2024**, **Gwendolyn Ulijasz** was permitted access to the marital residence for the limited purpose of retrieving certain personal belongings.
3. Prior to her arrival, Ms. Ulijasz sent a text message stating that she would take only her work-related items and clothing, would leave the remainder of the household contents in place, and that the residence security cameras could remain active so that **I would feel comfortable and reassured regarding what she removed**.
4. My **sole condition** for granting access was that Ms. Ulijasz **not enter my private office space**. I communicated this clearly and respectfully. I asked only that she please respect my office. I placed a written note on the office door requesting that the space not be entered, and I ensured the door was closed and locked.
5. Prior to her arrival, I also retrieved Ms. Ulijasz's mail from **PhysicalAddress.com**, which is a private mailbox service that decouples your mails delivery from your physical address as she represented to me that she believed her life was in danger from a past romantic partner(s), and I placed it in plain view on a table near the front door so that it would be immediately accessible to her. I did this specifically to avoid any later claim that her mail was being withheld.
6. During the access period, despite my express request and the clear notice on the door, Ms. Ulijasz **forced upon the doors to my locked office without permission**. This was the **only area of the residence** I had asked her not to enter.

7. **After entering my office, Ms. Ulijasz went up to a security camera and accused me of recording her against her will while speaking directly into a camera.** This accusation was made notwithstanding the fact that the security cameras were operating in the same manner they had throughout the marriage and remained active at **her own suggestion** to provide transparency and reassurance.
8. Upon my return to the residence, **I found this camera pulled from the wall and shattered on the floor.** It appeared to have been thrown at the ground and stepped on.
9. **Several cameras within the residence were damaged** after that visit and another stolen.
10. I replaced the stolen and broken cameras within the house shortly thereafter. Upon Ms. Ulijasz next visit to the house, **she later accused me in court on January 7, 2025, of installing “new” cameras** in an attempt to monitor her inappropriately.
11. **Pam Woodman, Ms. Ulijasz’s sister, corroborated this testimony in court falsely** and added that “dozens of surveillance devices” were found throughout the residence including one **“concealed within a plant” that “an off-duty police officer” found.** Pam Woodman made these claims despite never once visiting this residence prior. She had previously visited are old house on Travis St., but never this one.
12. The device found in the plant was actually not a surveillance device at all. **The entire event is caught on camera with full audio, and what is found is a smart hydrometer.** A digital device which notifies registered smart phones when a plant needs water. **And there was no confusion regarding what this device was, as Ms. Ulijasz herself (1) calls it by name (2) explains what it does (3) mocks Petitioner while speaking to him through the cameras in the house.** Pam’s voice is also caught within the room at this time instructing Petitioner to stop talking to the cameras.
13. At no time did I consent to Ms. Ulijasz entering my office, accessing equipment within that space, or handling my work materials. My conduct during this event was limited to granting access, remaining outside her areas, complying with her stated requests, and attempting to minimize conflict.
14. Following this incident, Ms. Ulijasz later made accusations inconsistent with the agreed-upon conditions of access, despite my efforts to document, accommodate, and limit the scope of entry.

I declare under penalty of perjury that the foregoing is true and correct.

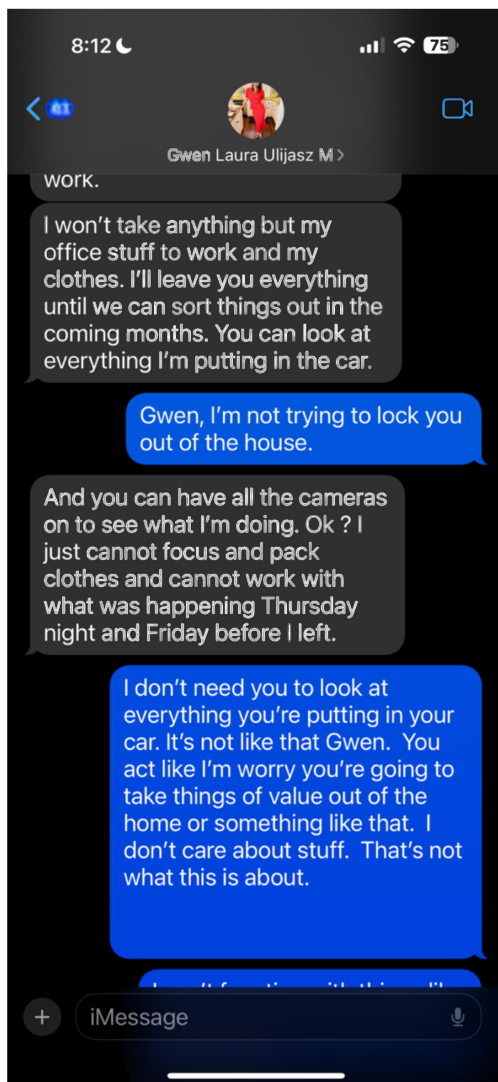
